



Widow/Widower Referral Terms

Our definition of a widow/widower: Someone who has lost a spouse, life partner, fiancée in death.

The referral terms and conditions are to confirm you understand the parameters as the “referrer” of the Widow or Widower you referred in the submission on Widows in Motion’s website. By referring the person entered in the submission form on our website, you understand they agree to be contacted by Widows in Motion, Inc. Form of contact can be by phone, email, written message/letter, virtually, or in person. The Widows in Motion organization will choose/identify which form works best for the organization and referred person.

Referral Recommendation:

- Widow/Widower has expressed the want or need for support and connection from an organization like Widows in Motion
- Referrer has recommended that the Widow/Widower should seek support and the Widow/Widower is open and wanting this support and connection for themselves.
- The referred person is in agreement to be contact by Widows in Motion.

Engagement: Widows in Motion sole purpose is to support widows and widowers in their own unique journey through widowhood. We will do our best to engage conversation whether through writing, virtually, or in person within the means of the organization in which we desire. However, there is no guarantee that the person referred will respond. Remember there is no fix to widowhood and at times it’s difficult to seek support through grief. This organization is just a resource in supporting someone who has lost a spouse/life partner. We are not professionals, and anything mentioned on all platforms is for educational purposes.

Duties of contact with Referrer: From time to time the Widows in Motion team may contact you as the referrer to engage in upcoming events, news including our monthly newsletter, and at times follow up regarding the referred person. (No confidential information will be shared with you, regarding the person you referred IE: Confidential information the referred person shares with the organization, unless of course there is a safety concern)

Indemnification: You as the referrer agree to indemnify and hold Widows in Motion, Inc free and harmless from and against any liability, expense, cost, loss, or damage which Widows in Motion may incur by reason of any act or omission of the widow/widower you are referring to the organization or its employees or agents with respect to the person being referred. No employment relations or agency relationship exists or is intended to exist.

Termination of Referral contact: If you wish to terminate the referral you submitted, as the “referrer” it is your responsibility to contact the Widows in Motion team via email at info@widowsinmotion.org so the organization can update the contact details accordingly and remove the referred person.

Right to Cancel, Modify or Terminate Referral: We reserve the right to cancel, modify or terminate the person referred at any time for any reason. We reserve the right to disqualify any user at any time from participation in all Widows in Motion platforms if we have a good faith belief that he/she has violated any Terms and Conditions, up to and including gross misconduct, sexual harassment, and discrimination.

Privacy: The personal information collected, processed and used as part of the Program will be used in accordance the utmost confidentiality.
